

#### 4. Rental Placements

- Owner rentals are facilitated through our Affiliated Partner network, including but not limited to MyResorts.
- Members may need to be registered with the relevant Affiliated Partner. Rentals and retractions can be managed telephonically via Holiday Options.
- Once placed on rental, the Owner may not rent or sell the interval privately without notifying the Affiliated Partner. If already confirmed via the Affiliated Partner, only their guest may check in. Until notification is received, the Affiliated Partner has first preference to rent or sell the interval.
- It is the Owner's responsibility to check the status of their ownership. If the same interval is rented/sold privately and via the Affiliated Partner without notice, the Affiliated Partner may demand cancellation or impose a penalty of up to 75% of the rental fee, deductible from funds due or future income.
- MyResorts sets dynamic nightly rates at its sole discretion. Owners cannot set prices or guarantee full-interval rentals. Nightly rentals may yield a higher return per night but are not guaranteed, and each night is rented at the Owner's risk.
- The Affiliated Partner will retain a commission of up to 35% (including VAT) of gross rental. No rentals are guaranteed.
- Payouts are processed after occupation during the month-end cycle and may take up to six (6) weeks to reflect. Net rental proceeds are paid to the shareblock and credited to the Owner's account. Any arrears will be settled first. Refunds must be requested from the managing agent.
- Payment requires a valid ID or passport, a bank confirmation letter, and cooperation with verification processes.
- Only intervals with all levies, management fees, and/or annual fees fully paid will be accepted. A 48-hour verification window (excluding weekends, public holidays, and office closures) applies to new listings.
- Owners authorise levy and ownership verification with the relevant resort/shareblock/club. Rental income may be withheld if the account is in arrears.
- For co-owned or entity-owned timeshare, the signatory warrants authority to act on behalf of all owners and indemnifies Holiday Options against related claims.
